

TERMS AND CONDITIONS TO ATTEND THE GENERAL MEETING

Each entire share is entitled to one vote. A shareholder may vote at the meeting by power of attorney.

The shareholders will be allowed to attend the General Meeting, by **giving proof of their identity, via passport or identity card and/or power of representation**. The right to participate in the General Meeting and to exercise the right to vote is subject to the registration of the shares in the name of the shareholder at least two (2) business days before the General Meeting designated "registration date" - either by their entry in the register of registered shares, either by their entry in the accounts of an authorized account- keeper or a liquidation body, without taking into account the number of shares held by the shareholder on the day of the general meeting.

Only people who are shareholders on the registration date will have the right to participate and vote at the General Meeting.

Each shareholder shall also notify the Company of their intention to participate in the General Meeting (in person or by proxy), stating the number of shares with which they intend to participate, no later than the "date of registration".

Only shareholders who have notified their intention to participate (in person or proxy) to the General Meeting on this date and have completed the required formalities will be authorized to attend and vote in the General Meeting.

The shareholders who are unable to attend personally the General Meeting may be represented by any person of their choice by proxy. **The proxy form shall be received by the liquidator by any means, duly completed, dated and signed, with supporting identity documents at latest on 9 November 2025 at 4.00 p.m.**

The proxy form can be sent via e-mail to fundteam@fundamentals.lu.

All proxies will be accepted in original or by e-mail with valid electronic/handwritten signature.

In case you attend in person, the original proxy shall however be presented to the scrutineer at the General Meeting of the shareholders.
